In the strategy process we refer to the MMI Network Strategy 2011-2015 that states: “We will make the MMI Network a real community of change for strengthening health systems”

- § “We will focus joint ventures on issues related to health systems strengthening.”
- § “We will focus joint international advocacy on the WHO.”
- § “We will develop new partnerships between NGOs and research institutions.”
- § “We will develop new spaces and tools for sharing know-how and joining forces.”



We (intend to) build on our reviewed Network Policy which states:
For the members of the Medicus Mundi International Network
promoting Health for All means:

- § Promoting universal health coverage in a sense of universal, equitable and affordable access to quality health services for all
- § Promoting strong national health systems
- § Promoting policies that address the social and political determinants of health,
- § Getting involved in global health policy, global health governance and global governance for health
- § Promoting health policies and practices based on evidence.
- § Critically reflecting their own role and contributions

The draft Network policy states, regarding the particular mandate or specific contribution of the Network:

- § Providing a platform for joint advocacy at a global level, with a focus on the World Health Organization and in close cooperation with other networks and campaigns promoting Health for All;
- § Fostering the visibility of the Network members and their activities by publishing their news, reports, statements, events and other contributions.
