### Concept Note: WHA77 Resolution on Climate Change and Health

#### Introduction

In the 15 years since the last World Health Assembly (WHA) resolution on climate change and health, understanding of the links between climate and health has advanced significantly. There is however currently a piecemeal approach to mitigation, adaptation and responding to loss and damage, threatening to leave many of the most vulnerable individuals and communities behind. This civil society coalition calls on World Health Organization (WHO) Member States to respond to this with an updated resolution to be adopted at the 77<sup>th</sup> session of WHA (WHA77) to draw together existing initiatives, tools and resources, better align and support the work of key global actors, and set new ambitions for Governments and the WHO.

This concept note presents notable international policy developments on climate change and health and provides a brief overview of the complex interlinkages between climate change and health. Building on this, it maps out some of the key issues a resolution could consider, including a core set of recommendations for action by the WHO Secretariat and Member States.

This note has been co-developed by a broad coalition of civil society organisations, academia and philanthropies which are actively committed to supporting Governments and the WHO to take comprehensive action on climate and health. It seeks to provide a summary of the key issues facing communities and a set of potential actions to help support and inform Member State negotiations on a resolution. Address health determinants and root causes of ill health in key policies across sectors. Advance the PHC approach and essential health system capacities for universal health coverage.

Improve health service coverage and financial protection to address inequity and gender inequalities.

Prevent, mitigate and prepare for risks to health from all hazards. Rapidly detect and sustain an effective response to all health emergencies.

# Joint Outcome 1.1. More climate-resilient health systems are addressing health risks and impacts

Climate-related risks to health systems and health and nutritional outcomes will be systematically assessed and addressed, in line with the drive for universal health coverage, a scaled-up primary health care approach and the wider societal goal of climate adaptation.


# Joint Outcome 1.2. Lower-carbon health systems and societies are contributing to health and well-being

Plans to reduce, where possible, the carbon footprint of health systems, supply chains and care services will be developed, tailored and implemented, accounting for different national and local contexts

### Assessment:


- Climate Change and Health higher on agenda of WHO
- Global Plan of Action welcome: governance and operationalisation
- Interrelation between the 6 pillars to be seen
- Fragmentation or synergetic approach beware of the silo approach
- Finance for implementation? Much hopes but assessment is bleak
- Relation with other institutions and UN governance regimes?
- Influence of other global health negotiations and geo-political gridlocks?
- Broader political economy of health and ecological crisis is missing (focus on co-benefits, not on limiting harm, justice, responsibility)
